Vitamin Industry News

- On March 12, BASF officially announced that production at its Ludwigshafen plant would gradually turn normal, with VA resuming production in early April 2025 and VE in mid-May 2025.
- On March 10, Indian Ministry of Commerce and Industry issued an announcement confirming an anti-dumping ruling on VA Palmitate originating from or imported from China, Switzerland, and the EU, recommending a five-year anti-dumping duty on the involved products.
- During the Shanghai FIC exhibition period, major domestic Vitamin C manufacturers suspended quotations. Since Dec,2024, the VC market price have been rapidly declining which discourages end-users from purchasing.
- It is indicated that rising prices of main raw materials, such as imported chromite and concentrated sulfuric acid, have pushed the production cost of VK3 to increase.
- Recently, Wanhua Chemical Group Co.,Ltd has officially commenced full-scale production of its complete VA industrial chain.
- Shandong Shangru Hongyi Fine Chemical Co., Ltd. has met regulatory requirements for its pilot workshop, which produces 70 tons of VK3 annually.



Market Price Overview

- According to feedback from end-users, DSM-Firmenich continued to suspend quotations for feed-grade VE to Chinese market as of March 6.
- On Mar 13th, Hubei Guangji and Shandong NB Fengyin quoted feed-grade
 VB2 at USD 10.4/KG FOB China.
- On Mar 13th, Yuxing and Hebei Huarong quoted VB12 1% at USD 11.5/KG FOB China.
- Jiangxi Tianxin Pharmaceutical Co., Ltd. has suspended quotation and contract signing for VE.



Market Situation-Mar(Week 1-2)

• On March 10, Indian Ministry of Commerce and Industry issued an announcement confirming an antidumping ruling on VA Palmitate originating from or imported from China, Switzerland, and the EU, recommending a five-year anti-dumping duty on the involved products. March 12th, BASF announced to resume production of vitamin A at its Ludwigshafen plant in early April. Wanhua Chemical's vitamin A workshop has been put into full production. Market price varies based on brands and shelf life and due to the overstock situation, dealing price is keeping going down. Currently, the market price for VA 1000 is around USD 26/kg FOB, while the price for VA 500 of Chinese origin is around USD 11/kg FOB.






Market Situation-Mar(Week 1-2)

• On March 12th, BASF announced to resume production of VE at its Eudwigshafen plant in mid May. Affected by BASF's production resumption announcement, some Chinese VE distributors are selling their products at low prices. However, mainstream manufacturers have suspended quotations, and some manufacturers have not yet resumed production, leading to a strong willingness to riase up prices. End-users tend to consume existing inventories. Currently, the market dealing price is around USD 14.5/kg FOB.



Market Situation-Mar(Week 1-2)

• The Chinese supply of VB2 is abundant. There is a severe overproduction situation with new market players keeping entering into the market. The actual market dealing price is slightly lower than average quotations. Attention should be paid to product availability from new manufacturers in the near future. Currently, the market dealing price is around USD10.2/kg FOB China.






Market Situation-Mar(Week 1-2)

 Some factories in India have declared force majeure on Niacin supply and recently manufacturers have raised offer prices. However, in short terms, it is uneasy for the market price to rise due to the sufficient supply. Currently, the market price is around USD4.4/kg FOB.






Market Situation-Mar(Week 1-2)

Attention should be paid to the actual dealing price of manufacturers and also the delivery progress. Some Chinese traders are offering around USD27/Kg FOB.

















• During the Shanghai FIC exhibition period, major domestic Vitamin C manufacturers suspended quotations. Since Dec. 224, the VC market price have been rapidly declining which discourages end-users from purchasing. The VC market price is around USD2.6/kg FOB and the VC 35% market price is around USD1.6/kg FOB.
